Audit management letter

With regard to the financial statements I have the following comments:

- This is the second year in succession that the Lesmurdie Senior High School has reported a substantial loss. It is clearly evident that the losses are generated by donations to Lesmurdie Senior High School and passing on income from the canteen to the school is general practice, but please ensure that enough funds remain to ensure the canteen can operate throughout the year.
- Percentage gross profit from trading: The percentage gross profit from trading dropped to 59% in 2023 compared to prior years of 89% (2022), 85% (2021) and 78% (2020). See table below. Please ensure the following are occurring.
 - All cash sales have been accounted for and has not been used for other purchases not entered into Xero.
 - There is no significant cash on hand at 31 December 2023.
 - Has there been a reduction in the margins on Food Sales.
 - Are catering sales done at cost or is there a profit in this amount.
 - Closing inventory is accurate.
 - o Call me if you need to discuss further.
